The IGF Board of Directors met on 11 June 2024 with the following matters being discussed.		
2023 Financial Statements Auditors Report	The Board approved the Report of the auditor to the Board of Directors of International Golf Federation (IGF) on the 2023 financial statements.	
Financial Report	The Executive Director presented the meeting the financial report which included a financial dashboard, the IGF Balance Sheet, Profit & Loss Statements as of 31 March 2024, cash flow forecast, and actual results compared to the overall budget of the IGF, the revised budget for the Paris 2024 Olympic Games and the Paris 2024 Sport Delivery Project (SDP).	
Paris 2024 Olympic Games	 Operations The IGF administration continues to monitor closely the resolution of issues and mitigation of high risks and formally report on these to the IOC, ASOIF and Paris 2024 through the IGF Risks and Issues Report and while some issues have been resolved in recent weeks, it was acknowledge that there are still several that remain unresolved, which will continue to be pursued. 	
	Agronomy	
	It was reported that the golf course will be in great agronomical shape and that the players will find the course be able to compete in the best possible conditions.	
	Communications	
	The latest version of the IGF website was successfully launched on 22 April 2024. Since the launch, site traffic is being monitored, and through our communications strategy, we aim to significantly increase traffic leading up to and during Games-time.

Dakar 2026 Youth Olympic Games (YOG)	Meeting was informed that the IOC Executive Board had approved the sports programme for 2026 Dakar YOG, and that golf was omitted from the programme.
LA 2028 Olympic & Paralympic Games	Event Delivery
	Discussions continue with LA 2028 to engage the IGF and its membership into the delivery of both the competition and sports services as well as the outside the ropes event delivery.
Olympic Esports Games	Meetings were held during The Players Championship between the IGF, IOC, the PGA Tour, 2K and TGL to ensure golf's presence in the Olympic Programme for both the simulator and console disciplines ahead of this announcement.
